TERMS AND CONDITIONS:

- Villa Plenilunio strongly suggests that all the wedding planners and clients arrange the permit with the Local Banjar & Police to use any fireworks or fire shows.
- Check-in Time: 2 PM and Check-out time 11 AM.
- The booking will be recognized as "confirmed" once the 50% deposit of the total invoice has occurred.
- The balance of total payment is due 30 days prior to arrival in all seasons. In the case of a last-minute booking, a 100% deposit is required prior to arrival. Villa Plenilunio reserves the right to treat the booking as cancelled if any part of the balance remains unpaid by the due date
- Payments can be made by bank transfer or cash.
- Presence of children and infants has to be communicated before confirming the reservation.
- Security deposit of 15.000.000 IDR is required. Guests are responsible for looking after the property, leaving it in good and clean condition. Guests are obliged to partake in payments for damages, breakages or losses that they are responsible for during the period of their stay. Villa Plenilunio reserves the right to reclaim the hired property if the hirer, members of the guest party or guest visitors cause excessive damage or mess.
- The number of persons occupying a bedroom villa must not exceed the maximum number stated in the room description unless by prior arrangement. Everyone occupying the room villa must be listed in the booking information, including small children. The accommodation cannot be shared or sublet, and only the persons shown in the booking form are permitted to stay on the property.
- Villa Plenilunio reserves the right to refuse any venue booking.
- Failure to comply will render the booking void, and the Villa will pay no compensation.

CANCELLATION BY THE VILLA:

Villa Plenilunio has the right to cancel a Client's booking in the following circumstances:

- at any time facing Force Majeure Clauses.
- if the Client has failed to pay the total balance by the due date. If the cancellation occurs for the reasons above, then Villa has no obligation to make payments that have been received or compensation in any form.

CANCELLATION BY THE CLIENT:

- Cancellations by a client must be written and signed by the individual who made the booking, either by special delivery or e-mail.
- For any cancellation that happens by the client's wishes for any reason, then:
 - a. Deposit payment is forfeited and belongs to the Villa
 - b. Villa reserves the right to 50% (fifty per cent) of the total loss of the entire deposit payment.
- Any cancellation less than 90 days prior to arrival are subjected to a complete forfeiture of deposit to compensate the Villa for the loss of other potential bookings that have been turned down once the booking has been confirmed
- Any postponement of an existing event needs to be confirmed 30 days before the original date of the event
- Postponement of existing events is allowed based on availability
- The new dates can be selected in the next 12 months starting from the original date of the event date

COMPLAINTS:

The Management will make every attempt for the Guest's to have an enjoyable stay at the Villa. However, should the GUEST have a problem with the Villa during the Rental Period, he must immediately inform the Management, who will endeavor to rectify the issue.
